RESOLUTION NO. 2000-074

RESOLUTION REQUESTING THE OIC, CITY TREASURER OF ORMOC, TO SUBMIN SCONEST A CERTIFIED LIST OF REAL PROPERTY TAX DELINQUENCIES WHICH REMAINED UNCOLLECTED FOR AT LEAST (1) YEAR, INDICATING THEREIN, THE NAMES OF THE DELINQUENT TAXPAYERS, THE PERIOD AND AMOUNT OF DELINQUENCIES, AND THE REASON/S FOR SUCH NON-COLLECTION, AND THE ACTION TAKEN THEREON, IF ANY.

WHEREAS, Article 360 of RRILGC, as implemented by Section 71 of Tax Ordinance No. 93-03 mandates the City Treasurer to prepare a certified list of all real property tax delinquencies which remained uncollected or unpaid for at least one (1) year, and to submit the said document to the Sanggunian on or before December 31st, of every year immediately succeeding the year in which the delinquencies were incurred;

WHEREAS, records of this Sanggunian show that the last list of real property tax delinquencies submitted was, as of December 31st, 1997;

WHEREAS, per COA Report for 1999, "the collection of prior years RPT fell short by 64.1% or F1.2 million of 1999 target of F1.8 million due to the City Treasurer's failure to request assistance from the Sangguniang Panlungsod in the enforcement of remedies collection. "X X X"

WHEREAS, Article 350 of the RRILGC, as implemented by Section 61 of Ordinance No. 93-03 provides: "Without prejudice to criminal Tax Ordinance No. 93-03 provides: prosecution under the Revised Penal Code and other applicable laws, any local treasurer or his deputy who fails to issue or execute the warrant of levy within one (1) year from the time the tax becomes delinquent or

within thirty (30) days from the date of the issuance thereof, or who is found guilty of abusing the exercise thereof in an administrative or judicial proceeding shall be dismissed from the service."

WHEREFORE, on motion of the Chairman, Committee on Ways and Means, City Councilor Mariano Y. Corro, jointly seconded by City Councilors Alfredo F. Capahi and Fernando P. Parrilla; be it -

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution REQUESTING THE OIC CITY TREASURER OF ORMOC TO SUBMIT SOONEST A CERTIFIED LIST OF REAL PROPERTY TAX DELINQUENCIES WHICH REMAINED UNCOLLECTED FOR AT LEAST ONE (1) YEAR, INDICATING THEREIN, THE NAMES OF THE DELINQUENT TAXPAYERS, THE PERIOD AND AMOUNT OF DELINQUENCIES, AND THE REASON/S FOR SUCH NON-COLLECTION, AND THE ACTION TAKEN THEREON, IF ANY;
