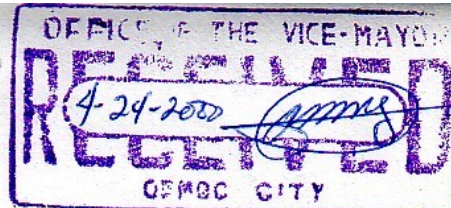
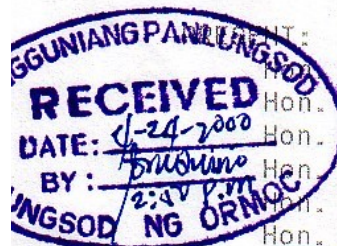

RESOLUTION NO. 2000-075

A RESOLUTION JOINING THE WHOLE WORLD IN THE OBSERVANCE  
AND COMMEMORATION OF THE EARTH DAY ON APRIL 22, 2000  
AND EVERY YEAR THEREAFTER.

WHEREAS, the Honorable Secretary Alfredo S. Lim of the Department of the Interior and Local Government issued Memorandum Circular No. 2000-38 dated April 11, 2000 the subject of which is Earth Month Celebration wherein Earth Day Network 2000 Phils. is spearheading the conduct of activities in celebration of the 22nd of April of every year as Earth Month;
