RESOLUTION NO. 2000-077

A RESOLUTION DISAPPROVING BARANGAY ORDINANCE NO. 01 S. 2000 OF BARANGAY COUNCIL OF BARANGAY BANTIGUE, THIS CITY, ENTITLED, "AN ORDINANCE OF NO AGE LIMIT CURFEW HOUR FROM 10:00 P.M. TO 4:00 A.M." FOR BEING INCONSISTENT WITH LAW.

WHEREAS, this Sanggunian is in receipt of Ordinance No. 01 s. 2000 of the Barangay Council of Barangay Bantigue, this city, entitled, "AN ORDINANCE OF NO AGE LIMIT CURFEW HOUR FROM 10:00 P.M. TO 4:00 A.M.";

WHEREAS, the Sangguniang Panlungsod ng Ormoc is by law granted the Power of Review as to whether said ordinance is consistent with law and city ordinances (Sec. 57, 1999 LGC);

WHEREAS, upon review of said ordinance by this august Body, it was found out that said ordinance is inconsistent with law for it violates the constitutional rights of a person;

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, jointly seconded by City Councilors Dennis Y. Capuyan and Eduardo P. Tan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution DISAPPROVING BARANGAY ORDINANCE NO. 01 S. 2000 OF BARANGAY COUNCIL OF BARANGAY BANTIGUE, THIS CITY, ENTITLED, "AN ORDINANCE OF NO AGE LIMIT CURFEW HOUR FROM 10:00 P.M. TO 4:00 A.M." FOR BEING INCONSISTENT WITH LAW;

ADOPTED, April 27, 2000.
