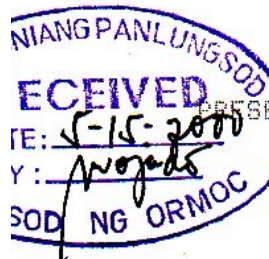

WHEREAS, this Sanggunian is in receipt of a communication dated 27 April 2000 from the Honorable City Mayor Eufrocino M.
