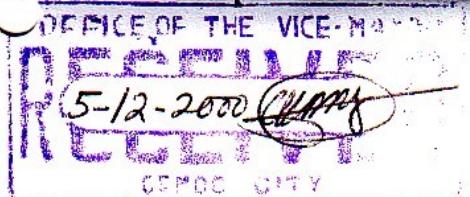
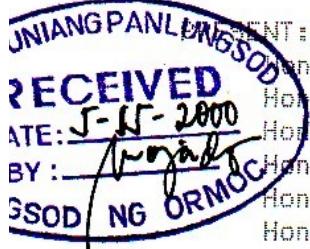

RESOLUTION NO. 2000-082

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE  
AGAINST THE PROVISION FOR PRIOR YEAR'S OBLIGATION, A  
NON-OFFICE ACCOUNT IN OUR 2000 ANNUAL BUDGET, THE  
AMOUNT OF TWO HUNDRED SEVENTY FIVE THOUSAND THREE  
HUNDRED TWENTY THREE PESOS & 89/100 (₱275,323.89) FOR  
THE PAYMENT OF ELECTRIC BILLS OF ORMOC WATERWORKS  
DIVISION FOR THE PERIOD AUGUST 1999 - DECEMBER 1999.

WHEREAS, this Sanggunian is in receipt of the letter dated 2 May 2000 from Engr. Gervacio L. Germano, Ormoc Waterworks Superintendent II, addressed the Honorable Sangguniang Panlungsod, requesting authority to charge against Current Appropriation (2000) their electric bills in the amount of TWO HUNDRED SEVENTY FIVE THOUSAND THREE HUNDRED TWENTY THREE & EIGHTY NINE CENTAVOS (₱275,323.89) for the period August 1999 - December 1999;

WHEREAS, the City Budget Officer through 3rd Indorsement dated 5 May 2000 has recommended that authority be granted the City Accountant to charge said obligation against Provision for Prior Year's Obligation, a non-office appropriation of the 2000 Annual Budget;

WHEREAS, the ICO-City Treasurer through 5th Indorsement has stated that said obligation be charged against Provision for Prior Year's Obligation, subject to accounting and auditing rules and procedures;

WHEREFORE, foregoing premises considered, on motion of City Councilor Alfredo F. Capahi, Chairman, Committee on Finance, jointly seconded by City Councilors Claudio P. Larrazabal & Fe S. Lladoc;

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE CITY ACCOUNTANT TO CHARGE AGAINST THE PROVISION FOR PRIOR YEAR'S OBLIGATION, A NON-OFFICE ACCOUNT IN OUR 2000 ANNUAL BUDGET, THE AMOUNT OF TWO HUNDRED SEVENTY FIVE THOUSAND THREE HUNDRED TWENTY THREE PESOS & 89/100 (P275,323.89) FOR THE PAYMENT OF ELECTRIC BILLS OF ORMOC WATERWORKS DIVISION FOR THE PERIOD AUGUST 1999 - DECEMBER 1999;

ADOPTED, May 11, 2000.
