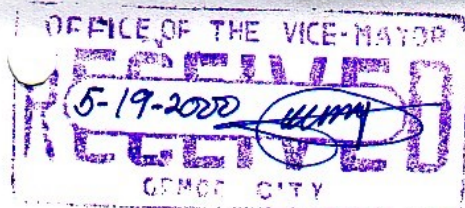
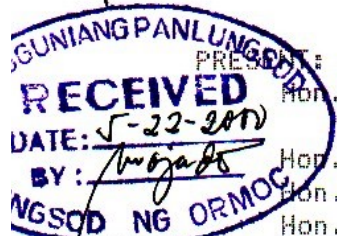

CITY;



Chairmen/Treasurers of the barangays concerned, -all in Ormoc City;


