


A RESOLUTION APPROVING RESOLUTION NO. 01 SERIES OF 2000 OF THE LOCAL BIDS AND AWARDS COMMITTEE, ORMOC CITY, ENTITLED: "A RESOLUTION APPRAISING THE LEASE OF JEEPNEY TERMINAL FOR THE PERIOD MAY 25 TO JULY 15, 2000 OR FIFTY-TWO (52) CALENDAR DAYS IN THE AMOUNT OF NOT LESS THAN THREE HUNDRED FIFTY THOUSAND (P350,000.00) PESOS," SUBJECT TO THE PROVISION OF SEC. 198 OF COA CIRCULAR NO. 92-386 DATED OCTOBER 20, 1992.
