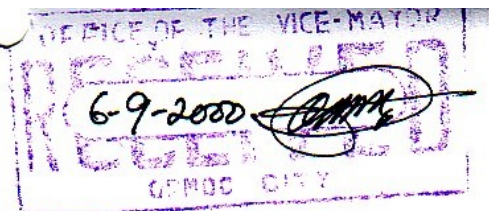
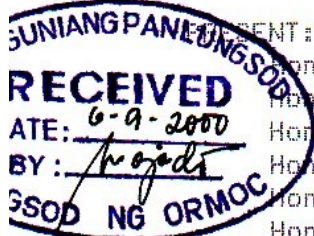

ADOPTED, June 08, 2000.


RESOLVED FURTHER, to furnish copies of this resolution each to His
