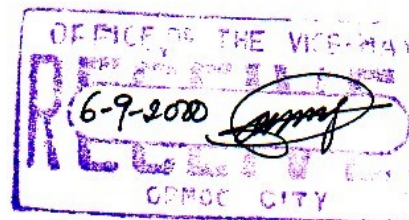
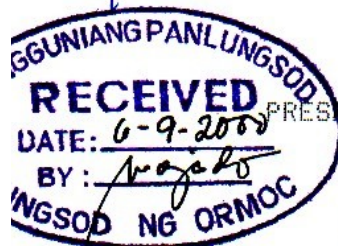

RESOLUTION NO. 2000-097

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH, REPRESENTED BY ITS REGIONAL DIRECTOR, DR. LILIA OBSEQUIO-ARTECHE FOR THE IMPLEMENTATION OF THE PROJECT "SUSTANSYA PARA SA MASA MATCHING GRANT".

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 29 May 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr., of the Sustansya ng Masa Project Proposal intended for 2nd & 3rd degree malnourished preschoolers from five (5) Lingap beneficiaries namely: Barangay Magaswe, Mahayag, Boroc, Batuan & Bagong, all of this city;

WHEREAS, said project proposal mentions of food supplementation coupled with nutrition education, growth monitoring and promotion of beneficiaries, all of which form part of the Administration's program to fight malnutrition in the society and hopefully obtain healthy and well-nourished children in the future;
