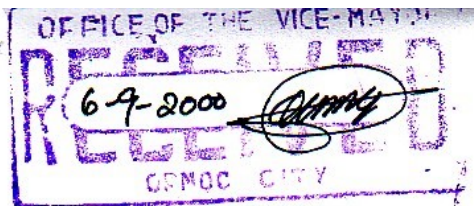

RESOLUTION NO. 2000-098

A RESOLUTION ALLOWING THE BAYAN TELECOMMUNICATIONS, INC., (BAYANTEL) TO INITIALLY INSTALL 15 PAYPHONES IN ORMOC CITY MOSTLY IN PUBLIC BUILDINGS AND OTHER AREAS WHERE SAID SERVICE IS NEEDED.

WHEREAS, this Sanggunian is in receipt of a letter dated 7 June 2000 from Mr. Arnold P. Flores, Account Manager, Bayan Phone Card, Bayan Telecommunications, Inc., Tacloban City, asking permission from this council to allow the initial installation of 15 payphone installations in the City of Ormoc mostly in public places;

WHEREAS, BAYANTEL has identified certain sites in Ormoc City ideal for said project and at the same time enjoining the City Council in recommending areas where said services is needed, hence, this request for permission;

WHEREAS, the Sangguniang Panlungsod ng Ormoc, mindful of the benefits that will be derived therefrom, has considered the same reasonable and of great help to those who are in need of telecommunication services;

WHEREFORE, foregoing premises considered, on motion of City Councilor Eduardo P. Tan, Chairman, Committee on Transportation and Communications, jointly seconded by City Councilors Sotero M. Pepito and Fe S. Lladoc; be it
