RESOLUTION NO. 2000-102

A RESOLUTION RESPECTFULLY REQUESTING THE INSTITUTE OF INSTITUTE OF CIVIL ENGINEERS (PICE), THE INSTITUTE OF INTEGRATED ELECTRICAL ENGINEERS (IIEE), THE UNITED ARCHITECTS OF THE PHILIPPINES (UAP) AND THE ASSOCIATION OF REAL ESTATE DEVELOPERS, ORMOC CHAPTERS TO CONDUCT AN INSPECTION OF THE ORMOC CITY HALL WHETHER OR NOT THE SAME IS STILL SAFE FOR OCCUPANCY, AND TO SUBMIT THEIR REPORT TO THIS SANGGUNIAN SOONEST.

WHEREAS, this Sanggunian passed Resolution No. 2000-046 dated 02 March 2000 entitled, "A RESOLUTION AFFIRMING THAT THE CONSTRUCTION OF A NEW ORMOC CITY HALL AT THE GOVERNMENT CENTER, IS HIGHLY NECESSARY";

WHEREAS, in the Post-Investigation Report dated 23 May 2000 of the fact-finding committee as created by DILG RO 2000-169 dated 18 May 2000, one of the recommendations by the committee is hereunder quoted as follows:

"The committee members however would like to suggest that in order to determine once and for all if the proposed construction is really expensive and unnecessary, a team composed of professionals engineers, architects, real estate developers and others in similar profession would have to be created so that an independent and authoritative conclusion can be obtained. Based on the findings of this group, the National government will now have a basis in ordering for the stoppage of the project.

WHEREAS, said construction of a new City Hall is based on the Narrative Inspection Report dated 18 February 2000 of Engr. Antonio Z. Padayao, City Engineer, this city; (Copy of said report is hereto attached.)

WHEREAS, in order to further validate said report of the City Engineer as regards the status of the old City Hall, it is the intention of this august Body to seek and utilize the expertise and opinion of the Philippine Institute of Civil Engineers (PICE), the Institute of Integrated Electrical Engineers (IIEE) the United Architects of the Philippines (UAP) and the Association of Real Estate Developers - Ormoc Chapters to remove any cloud of doubt as to the veracity of aforementioned report, and further request said associations to submit to the Sangguniang Panlungsod ng Ormoc a written report of their findings;

WHEREAS, for purposes of giving better public service to its constituents, this august Body believes that a new and a better city Hall is necessary, hence, this request;

WHEREFORE, foregoing premises considered, on motion of City Councilor Sotero M. Pepito, jointly seconded by Fe S. Lladoc and Claudio P. Larrazabal; be it

RESOLVED, AS IT IS NEREBY RESOLVED, to pass a resolution RESPECTFULLY REQUESTING THE PHILIPPINE INSTITUTE OF CIVIL ENGINEERS (PICE), THE INSTITUTE OF INTEGRATED ELECTRICAL ENGINEERS (IIEE), THE UNITED ARCHITECTS OF THE PHILIPPINES (UAP) AND THE ASSOCIATION OF REAL ESTATE DEVELOPERS, ORMOC CHAPTERS TO CONDUCT AN INSPECTION OF THE ORMOC CITY HALL WHETHER OR NOT THE SAME IS STILL SAFE FOR OCCUPANCY, AND TO SUBMIT THEIR REPORT TO THIS SANGGUNIAN SOONEST;

ADOPTED, June 15, 2000.
