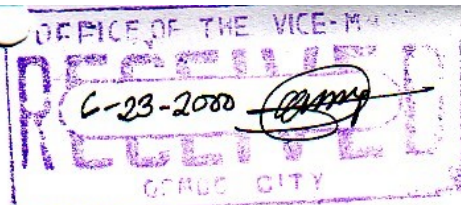

Parrilla and Fe S. Lladoc; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution

ADOPTED, June 22, 2000.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
