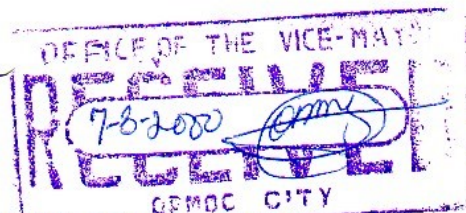
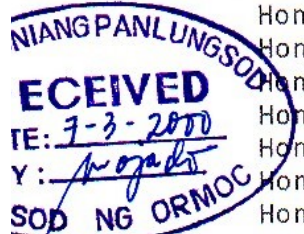

ADOPTED, June 30, 2000.


