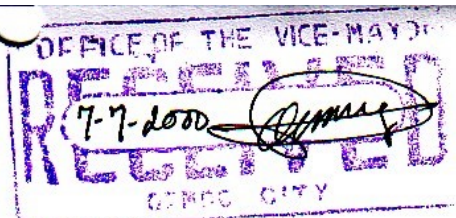
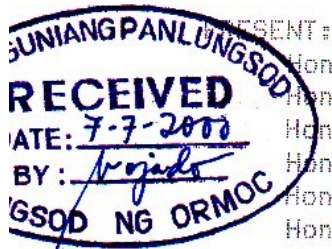

RESOLUTION NO. 2000-112

A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 04 OF
BARANGAY CATMON, THIS CITY, ENTITLED: "AN ORDINANCE
FIXING THE RATES OF BARANGAY CLEARANCE FEES, PERMITS
AND OTHER CHARGES AND FEES FOR THE AVAILMENT OF USE OF
VARIOUS PROPERTIES AND SERVICES OF THE BARANGAY".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 04
of the Barangay Council of Catmon, this city, entitled: "AN ORDINANCE
FIXING THE RATES OF BARANGAY CLEARANCE FEES, PERMITS AND OTHER CHARGES
AND FEES FOR THE AVAILMENT OF USE OF VARIOUS PROPERTIES AND SERVICES OF
THE BARANGAY";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited ordinance at issue (and all other ordinances of the
Sangguniang Barangay in Ormoc City), is by law, granted the Power of
