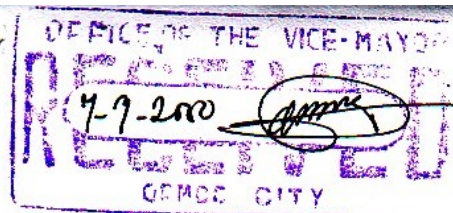
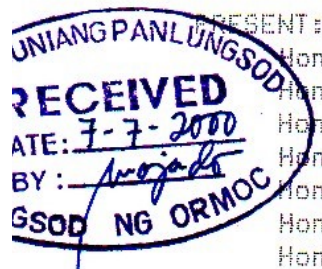

A RESOLUTION ENDORSING THE REQUEST OF ASIAN MARINE
TRANSPORT CORPORATION TO OPERATE AN IDEAL RO-RO TYPE
VESSEL FOR THE CEBU-ORMOC-CEBU ROUTE.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 27 April 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr., re: letter of MS. GLORIA N. SENO, President, Asian Marine Transport Corporation, requesting the Sangguniang Panlungsod for an endorsement that said company be permitted to operate a ro-ro type passenger cargo ferry for the Cebu-Ormoc-Cebu route;

WHEREAS, considering the need for additional seacraft to serve the riding public not only from Ormoc City but also from its neighboring towns and municipalities, this Sanggunian believes that the operation of Asian Marine Transport Corporation for the aforementioned route will promote public interest and convenience hence, same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Eduardo P. Tan, Chairman, Committee on Transportation & Communications, duly seconded by City Councilor Dennis Y. Capuyan; be it

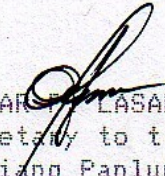

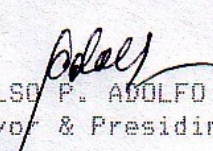
