

RESOLUTION NO. 2000-115

RESOLUTION ENDORSING THE PROJECT ENTITLED: "IMPROVEMENT WATER SUPPLY FACILITIES AND MEDICAL ASSISTANCE IN AMOUNT OF THIRTY FIVE MILLION (P35M) AND FIVE MILLION RESUS (P5M) RESPECTIVELY," FOR FUNDING SUPPORT THE LOCAL GOVERNMENT SERVICE EQUALIZATION FUND UNDER (LGSEF) .

WHEREAS, R.A. 7160, otherwise known as the Local Government Code of " delegated specific functions and responsibilities to government units (LGUs) particularly on the effective and efficient delivery of basic services and facilities at the local level;

WHEREAS, there is an urgent need to provide fund assistance to LGUs in order to alleviate their financial burdens in carrying out the devolved functions and responsibilities, as specified by the Code;

WHEREAS, Executive Order No. 48, Series 1998, established a Program for Devolution Adjustment and Equalization Fund, renamed as Local Government Service Equalization Fund (LGSEF), which is primarily aimed at enhancing the capacities of LGUs to fully and effectively exercise their devolved functions, services and facilities;

WHEREAS, the City of Ormoc desires to implement the project, entitled, "IMPROVEMENT OF WATER SUPPLY FACILITIES AND MEDICAL ASSISTANCE IN THE AMOUNT OF THIRTY FIVE MILLION (P35M) AND FIVE MILLION (P5M) PESOS RESPECTIVELY" which is a local priority project congruent with the socio-economic and development agenda of the Estrada Administration;

WHEREAS, the Ormoc City Government lacks the financial capabilities to implement the aforementioned project;

NOW, THEREFORE, on joint motion of City Councilor Dennis Y. Capuyan, Chairman, Committee on Health and City Councilor Claudio P. Larrazabal, Chairman, Committee on Infrastructures, duly seconded by City Councilor Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution ENDORSING THE PROJECT ENTITLED: "IMPROVEMENT OF WATER SUPPLY FACILITIES AND MEDICAL ASSISTANCE IN THE AMOUNT OF THIRTY FIVE MILLION (P35M) AND FIVE MILLION PESOS (P5M) RESPECTIVELY," FOR FUNDING SUPPORT UNDER THE LOCAL GOVERNMENT SERVICE EQUALIZATION FUND (LGSEF);
