RESOLUTION NO. 2000-116

A RESOLUTION RESPECTFULLY AND EARNESTLY REITERATING  
RESOLUTION NO. 99-106 ENTITLED, "A RESOLUTION  
RESPECTFULLY REQUESTING THE HONORABLE MA. VICTORIA L.  
LOCSIN, REPRESENTATIVE OF THE FOURTH DISTRICT OF LEYTE,  
TO SPONSOR A BILL IN CONGRESS DECLARING JUNE 29 OF  
EVERY YEAR A SPECIAL NON-WORKING PUBLIC HOLIDAY IN  
ORMOC CITY TO BE KNOWN AS 'ORMOC CITY DAY'".

WHEREAS, this Sanggunian on July 8, 1999 adopted Resolution No. 99-106, copy of which is hereto attached for ready reference;

WHEREAS, as stated in the aforementioned resolution, the feast day of other cities, particularly that of Tacloban and Oroquieta are observed as a special nonworking public holiday through the enactment of Republic Act No. 7676, and Republic Act No. 7677, respectively;

WHEREAS, in the last City Fiesta of Ormoc (June 29, 2000), private schools, banks, and some national government offices based in Ormoc City, on their own volition, declared the day as a nonworking holiday;

WHEREAS, it is the sense of the members of this Sanggunian that to appropriately celebrate the feast day of Saints Peter and Paul, the patron saints of Ormoc City, June 29 of every year be declared a special nonworking public holiday in Ormoc City, so as to give the people of Ormoc City, the government officials and employees (both local and national who are based in Ormoc City), civic, sports, religious and non-government organizations, and private companies doing business in Ormoc City, the full opportunity to lead appropriate and meaningful celebrations, activities and programs participated in by them;



WHEREAS, the Congresswoman of the Fourth District of Leyte, Honorable Ma. Victoria Locsin who hails from Ormoc City, is earnestly requested to work for the passage of the desired law, declaring June 29 of every year a special nonworking public holiday in Ormoc City, to give the Ormocanons the same opportunity and privilege as the people of Tacloban and Oroquieta, in celebrating the feast day of their patron saints;

FOREGOING PREMISES CONSIDERED, on MASS MOTION of the Body; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RESPECTFULLY AND EARNESTLY REITERATING RESOLUTION NO. 99-106 ENTITLED, "A RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE MA. VICTORIA L. LOCSIN, REPRESENTATIVE OF THE FOURTH DISTRICT OF LEYTE, TO SPONSOR A BILL IN CONGRESS DECLARING JUNE 29 OF EVERY YEAR A SPECIAL NON-WORKING PUBLIC HOLIDAY IN ORMOC CITY TO BE KNOWN AS 'ORMOC CITY DAY'";

RESOLVED, FINALLY, to likewise furnish all the Congressmen of the Province of Leyte, the Province of Biliran and the Province of Southern Leyte, to request for their support in the enactment of the desired law.
