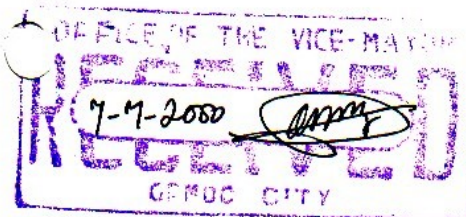
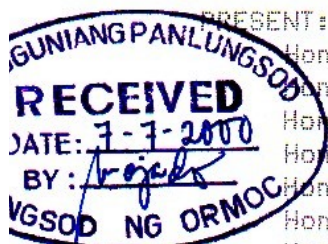

LOCATED AT GUINLIMHAN, BARANGAY VALENCIA, THIS CITY.

WHEREAS, this Sanggunian is in receipt of a letter dated 03 January
2000 from MS. MARICHU S. ALIGWAY and MR. MARIO ANTONIO PUTONG, project
proponents, requesting for a resolution interposing no objection and
granting social acceptability to the proposed poultry farm project of
