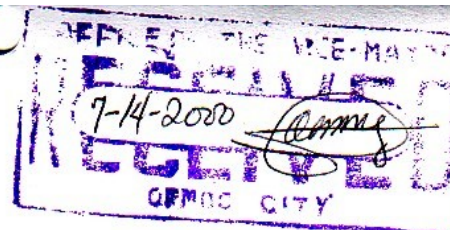
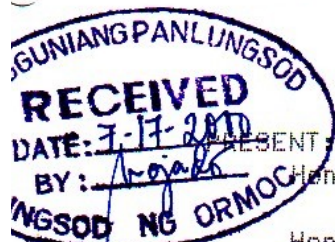

A RESOLUTION ADOPTING THE IMPLEMENTATION OF THE "MAUNLAD
NA NIYUGAN TUGON SA KAHIRAPAN PROGRAM" OF THE
PHILIPPINE COCONUT AUTHORITY PER DILG MEMORANDUM
CIRCULAR NO. 2000-62.

WHEREAS, this Sanggunian is in receipt of a letter dated 03 July
2000 from DILG, City Director Rodolfo A. Torcende encouraging the
passage of a resolution re: Support to the implementation of the
"Maunlad na Niyugan Tugon sa Kahirapan Program" of the Philippine
Coconut Authority per DILG Memorandum Circular No. 2000-62;

WHEREAS, said Memorandum Circular mentions of the said program
which is the Agrikulturang MAKAMASA program for coconuts aim to:

1. Improve the quality of life of farmers and farm workers
by increasing their gross annual income from Php 10,000
to Php 100,000 per hectare, and
2. Improve agricultural productivity through efficient
diversified farming systems in 2.1 million hectares of
available land spaces in - between coconuts which are
potent sources of food for the growing population of
the country.

WHEREAS, this august Body believes that said program is beneficial,
hence, the same be accorded due course of action;
