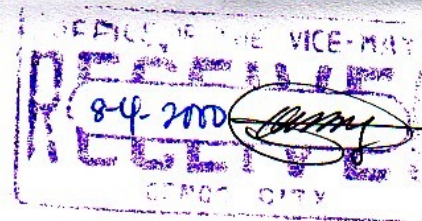
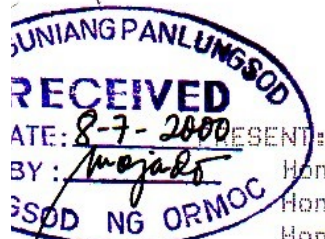

ADOPTED, August 03, 2000.

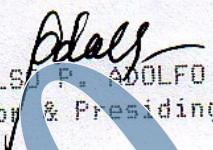
