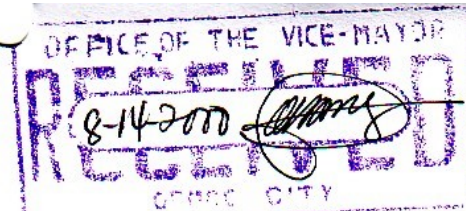
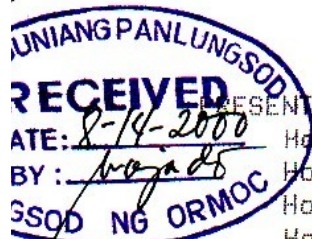

RESOLUTION NO. 2000-131

A RESOLUTION SUPPORTING THE REQUEST OF HONORABLE RODOLFO ASEDO, SR. PUNONG BARANGAY, DISTRICT IX, THIS CITY, AND FURTHER REQUESTING ISLACOM FOR THE DEMOLITION OF THE ISLACOM TOWER IN THEIR BARANGAY; REPAIR OF ABOUT TWENTY (20) SLABS OF CONCRETE CANAL COVER DAMAGED DURING THE CONSTRUCTION IN 1997, REMOVAL OF THE ELECTRICAL TRANSFORMER BUILT ALONG J. NAVARRO STREET AND TO TRANSFER THE SAME INSIDE THE ISLACOM COMPOUND WITHIN SIX (6) MONTHS FROM THE DATE OF RECEIPT OF THIS RESOLUTION.

WHEREAS, this Sanggunian is in receipt of a letter dated 11 July 2000 from Rodolfo Aseo, Jr., Punong Barangay, District IX, this city requesting for the demolition of the said ISLACOM tower in their barangay;

WHEREAS, said letter has stated that said request is already their second endorsement in behalf of the barangay;

WHEREAS, it can be recalled that the Sangguniang Panlungsod ng Ormoc passed Resolution No. 97-171 dated 18 September 1997 entitled, "A RESOLUTION EXPRESSING THE SENTIMENT OF THE 7TH SANGGUNIANG PANLUNGSOD OF ORMOC SUPPORTING THE STAND OF BARANGAY DISTRICTS 7, 8, 9, 10, 11 AND 18 OPPOSING THE CONSTRUCTION OF THE ISLACOM TOWER AT BARANGAY DISTRICT 9" for the reasons stated therein;

WHEREAS, considering the danger brought about by the said tower in the area and that ISLACOM has not acted on the problem for sometime, this august Body believes that it is but reasonable enough for the concerned barangays to act on the problem as soon as possible;

WHEREFORE, foregoing premises considered, on motion of City Councilor Eduardo P. Tan, Chairman, Committee on Transportation and Communications, duly seconded by City Councilors Fe S. Lladoc and Chiqui B. Labagala ; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution SUPPORTING THE REQUEST OF HONORABLE RODOLFO ASEO, SR. PUNONG BARANGAY, DISTRICT IX, THIS CITY, AND FURTHER REQUESTING ISLACOM FOR THE DEMOLITION OF THE ISLACOM TOWER IN THEIR BARANGAY; REPAIR OF ABOUT TWENTY (20) SLABS OF CONCRETE CANAL COVER DAMAGED DURING THE CONSTRUCTION IN 1997, REMOVAL OF THE ELECTRICAL TRANSFORMER BUILT ALONG J. NAVARRO STREET AND TO TRANSFER THE SAME INSIDE THE ISLACOM COMPOUND WITHIN SIX (6) MONTHS FROM THE DATE OF RECEIPT OF THIS RESOLUTION;
