RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN, FOR BEHALF OF THE CITY GOVERNMENT OF ORMOC, A EMORANDUM OF AGREEMENT WITH NATIONAL DAIRY AUTHORITY, REPARSENTED BY ITS OIC-ADMINISTRATOR DR. LIBERTADO C. CRUZ FOR THE IMPLEMENTATION OF THE "NDA-LGU-ORMOC ONWINITY MILK FEEDING PROGRAM".

WHEREAS, this august Body is in receipt of 1st Indorsement dated 20 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr., requesting for a passage of a resolution authorizing him to enter into and sign for and in behalf of the City of Ormoc a Memorandum of Agreement (MOA) between the National Dairy Authority (NDA), represented by its OIC-Administrator, Dr. Libertado C. Cruz, for the implementation of the NDA-LGU-Ormoc Community Milk Feeding Program."

WHEREAS, said Memorandum of Agreement mentions that the NDA-LGU-Ormoc Community Milk Feeding Program aims to partially eradicate the malnutrition problem in Ormoc City through milk feeding some 352 identified malnourished children with 200 ml. Sachet fresh milk for a period of approximately six months or 120 working days;

WHEREAS. this august Body has considered said request reasonable and beneficial, hence, same be accorded due course of action;

WHEREFORE, on motion of Councilor Dennis Y. Capuyan, Chairman, Committee on Health, severally seconded by City Councilors Mari∉no Y. Corro, Fe S. Lladoc and Eduardo P. Tan; be it
