

RONALDO B. RESOLUTION ENDORSING TO HON. OVERSIGHT COMMITTEE ON DEVOLUTION CHAIRMAN, OVERSIGHT COMMITTEE ON DEVOLUTION THE PROJECTS HEREIN BELOW STATED, FOR FUNDING SUPPORT UNDER THE LOCAL GOVERNMENT SERVICE EQUALIZATION FUND (LGSEF).

WHEREAS R.A. 7160, otherwise known as the Local Government Code of delegated specific functions and responsibilities to Government Units (LGUs) particularly on the effective and efficient delivery of basic services and facilities at the 'local level;

WHEREAS, there is an urgent need to provide fund assistance to LGUs in order to alleviate their financial burdens in carrying out the devolved functions and responsibilities, as specified by the Code;

WHEREAS, Executive Order No. 48, Series 1998, established a Program for Devolution Adjustment and Equalization Fund, renamed as Local Government Service Equalization Fund (LGSEF), which is primarily aimed at enhancing the capacities of LGUs to fully and effectively exercise their devolved functions, services and facilities;

WHEREAS, the City Government of Ormoc desires to implement the following projects, namely:
