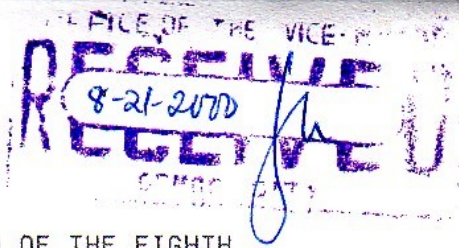
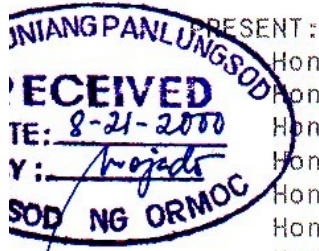

A RESOLUTION APPROVING THE CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 3, SERIES OF 2000, ENTITLED: "A RESOLUTION APPROVING THE CY 2000 SUPPLEMENTAL PROJECT IN THE AMOUNT OF SIX MILLION FIVE HUNDRED THOUSAND PESOS ONLY (P6,500,000.00) AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME."

WHEREAS, this Sanggunian is in receipt of Resolution No. 03 s. 2000 from the City Development Council, entitled: "A RESOLUTION APPROVING THE CY 2000 SUPPLEMENTAL PROJECT IN THE AMOUNT OF SIX MILLION FIVE HUNDRED THOUSAND PESOS ONLY (P6,500,000.00) AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME;"

WHEREAS, the Honorable City Mayor Eufrocino M. Codilla, Sr., through 1st Indorsement dated 8 August 2000, endorsed to the Secretary to the Sangguniang Panlungsod ng Ormoc CDC Resolution No. 03 s. 2000 for appropriate legislative action;

WHEREAS, said Resolution No. 3 s. 2000 has stated the following projects which are eligible for funding, to wit:

UNDER 20% DEVELOPMENT FUND:

1. Improvement of water supply facilities  
for various barangays.....P2,000,000.00
2. Street lighting for various barangays.... 3,500,000.00
3. Purchase of 100 KVA Transformer  
(3 Units)..... 500,000.00



CEO DEVELOPMENT PROJECT:

Road Concreting @ Brgy. Doña Feliza Mejia... 500,000.00

T O T A L.....P6,500,000.00

to be sourced from the 1999 General Fund Surplus;

WHEREAS, the City Development Council has approved the above projects since it is considered as priority and in accordance with the urgent need of the city;

WHEREFORE, foregoing premises considered, on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Infrastructures, severally seconded by City Councilors Alfredo F. Capahi, Dennis Y. Capuyan and Eduardo P. Tan; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING THE CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 3, SERIES OF 2000, ENTITLED: "A RESOLUTION APPROVING THE CY 2000 SUPPLEMENTAL PROJECT IN THE AMOUNT OF SIX MILLION FIVE HUNDRED THOUSAND PESOS ONLY (P6,500,000.00) AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME;"

ADOPTED, August 17, 2000.
