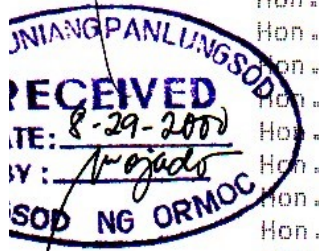
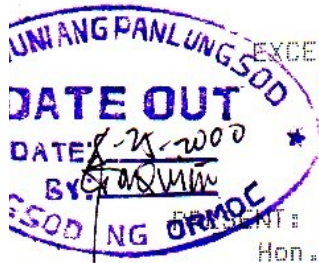
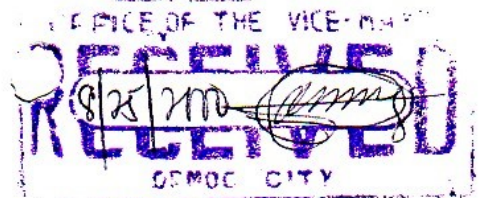

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN, FOR
AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A
MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE HEALTH
INSURANCE CORPORATION, REPRESENTED BY ITS PRESIDING AND
CHIEF EXECUTIVE OFFICER, ENRIQUE M. ZALAMEA, JR., FOR
THE IMPLEMENTATION OF INDIGENT COMPONENT OF THE
NATIONAL HEALTH INSURANCE PROGRAM (NHIP).

WHEREAS, this august Body is in receipt of 1st Indorsement dated 17
July 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr.,
requesting for a passage of a resolution authorizing him to enter into
and sign for and in behalf of the City Government a Memorandum of
Agreement (MOA) between the Philippines Health Insurance Corporation
(PhilHealth) for the implementation of Indigent Component of National
Health Insurance Program (NHIP);

WHEREAS, said Memorandum of Agreement states that consistent with
the vision and objectives of the National Health Insurance Programs, the
parties herein acknowledge their joint responsibility to provide a basic
package of needed personal health services to the under privileged and
indigent segment of herein local government units population through the
implementation of the Indigent Component of National Health Insurance
Program (NHIP), as mandated by law;

WHEREAS, this august Body has considered said request reasonable
and beneficial, hence, same is accorded due course of action;

WHEREFORE, on motion of Councilor Dennis Y. Capuyan, Chairman
Committee on Health, jointly seconded by Councilors Sotero M. Pepito and
Fe S. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION, REPRESENTED BY ITS PRESIDING AND CHIEF EXECUTIVE OFFICER, ENRIQUE M. ZALAMEA, JR., FOR THE IMPLEMENTATION OF INDIGENT COMPONENT OF THE NATIONAL HEALTH INSURANCE PROGRAM (NHIP);
