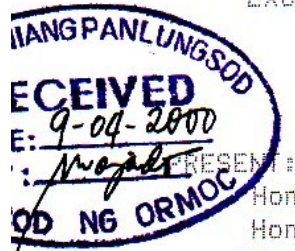

FILED BY SENATOR JUAN PONCE ENRILE PROVIDING FOR THE
INCREASE OF THE PERSONAL AND ADDITIONAL EXEMPTIONS ON
INDIVIDUAL TAXPAYERS.

WHEREAS, this Sanggunian is in receipt of Resolution No. 2000-178
from the Sangguniang Panlalawigan of Ifugao entitled, "RESOLUTION
