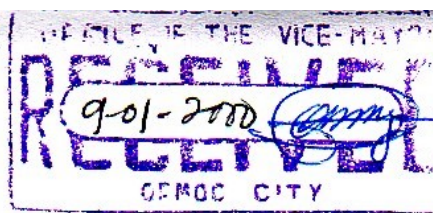
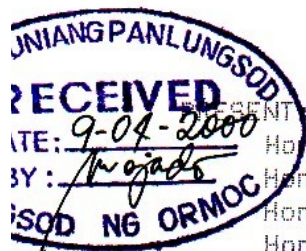

RESOLUTION NO. 2000-151

A RESOLUTION VEHEMENTLY OBJECTING THE PROPOSED INCREASE
IN FARE RATES OF THE SUPERCAT VESSELS PLYING THE ORMOC-
CEBU-ORMOC ROUTE.

WHEREAS, only last May 24, 2000 the fare of Supercat has been
increased from ₱330.00 to ₱385.00;

WHEREAS, the proposed fare rate increase per passenger of the
Supercat Vessel plying Ormoc-Cebu-Ormoc starting Sept. 1, 2000 is ₱25.00
making a total of ₱410.00;

WHEREAS, added to this fare rate of ₱410.00 a terminal fee of
₱20.00 is imposed or a total of ₱430.00;

WHEREAS, the commuters not only in Ormoc City but in the
neighboring towns including Tacloban City believe that said fare rate
increase is too high, expensive and exorbitant considering that the
services rendered is the same;

WHEREFORE, foregoing premises considered, on MASS MOTION of the
BODY; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution VEHEMENTLY
OBJECTING THE PROPOSED INCREASE IN FARE RATES OF THE SUPERCAT VESSELS
PLYING THE ORMOC-CEBU-ORMOC ROUTE;

ADOPTED, August 31, 2000.
