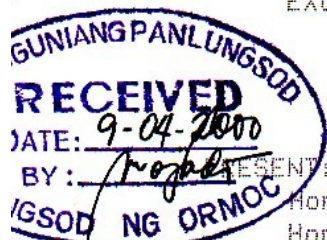

WHEREAS, the City of Ormoc has submitted to the League of Cities
for submission to the World Bank its City Development Strategy (CDS)
Proposal;
