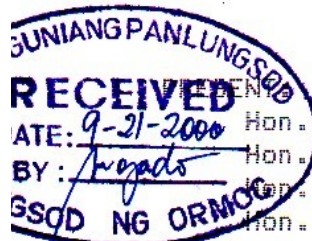

RESOLUTION NO. 2000-158

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE AMOUNT OF TWENTY FIVE THOUSAND PESOS (P25,000.00) AGAINST GRANTS, AIDS AND CONTRIBUTIONS, A CURRENT APPROPRIATION UNDER THE OFFICE OF THE CITY MAYOR, AS AID TO GIRL SCOUT OF THE PHILIPPINES, LEYTE COUNCIL.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 30 August 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr., the herein request for financial assistance in the amount of TWENTY FIVE THOUSAND PESOS (P25,000.00) to the Girl Scout of the Philippines, GSP Leyte Council to implement various GSP activities, programs and projects chargeable to the account Grants and Aids of the City Mayor's Office;

WHEREAS, the City Budget Officer through 4th Indorsement dated 8 September 2000 recommend that authority be granted to the City Accountant to charge said request against Grants, Aids and Contributions, a current appropriation under the Office of the City Mayor;

WHEREAS, Mrs. Salud A. Rivera, City Treasurer, through 6th Indorsement dated 12 September 2000 was stated that funds is available subject however to accounting and auditing rules & procedures;
