

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE AMOUNT OF TWENTY FIVE THOUSAND PESOS (\$25,000.00) AGAINST GRANTS, AIDS AND CONTRIBUTIONS, A CURRENT APPROPRIATION UNDER THE OFFICE OF THE CITY MAYOR, AS AID TO GIAL SCOUT OF THE PHILIPPINES, LEYTE COUNCIL.

WNEREAS, this Sanggunian is in receipt of 1st Indorsement dated 30 august 2000 from the Honorable City Mayor Eufrocino M. Codilla, Sr., the herein request for financial assistance in the amount of TWENTY FIVE THOUSAND PESOS (₱25,000.00) to the Girl Scout of the Philippines, GSP Leyte Council to implement various GSP activities, programs and projects chargeable to the account Grants and Aids of the City Mayor's Office;
