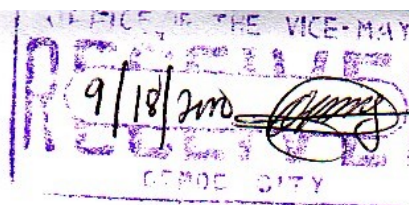
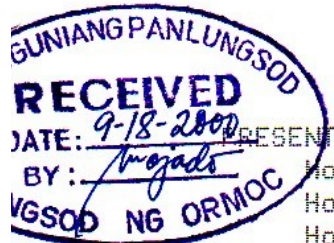

A RESOLUTION SUPPORTING RESOLUTION NO. 2000-350 OF THE  
SANGGUNIANG PANLALAWIGAN OF BULACAN DATED 27 JULY 2000,  
ENTITLED: "A RESOLUTION OF APPRECIATION AND GRATITUDE  
TO THE HONORABLE SUPREME COURT OF THE PHILIPPINES,  
SENATOR AQUILINO PIMENTEL, AND FORMER GOVERNOR ROBERTO  
M. PAGDANGANAN FOR THEIR CONTRIBUTION TO THE TRIUMPH OF  
LOCAL AUTONOMY THRU THE SUPREME COURT DECISION  
PERMANENTLY PROHIBITING ANY LIEN OR HOLDBACK THAT MAY  
BE IMPOSED BY THE NATIONAL GOVERNMENT ON INTERNAL

Revenue Allotment (IRA) due the Local Government Unit and prohibiting  
any lien or holdback that maybe imposed by the National Government for  
whatever purpose;

BODY; be it




