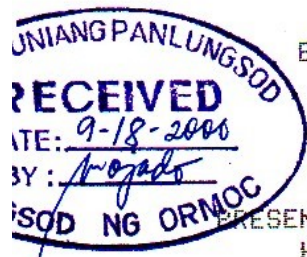

RESOLUTION NO. 2000-164

A RESOLUTION STRONGLY SUPPORTING HOUSE BILL NO. 11749
WHICH SEEKS TO INCREASE THE BENEFITS OF THE COUNTRY'S
BARANGAY OFFICIALS.

WHEREAS, a bill has been passed on third and final reading at the House of Representatives increasing the benefits of the nation's barangay officials;

WHEREAS, barangay leaders deserve an increase in benefits for they are the ones who stand at the front-line of governance and that it will enable also to promote a high level of service among barangay officials by helping them address their own needs;

WHEREAS, this measure will increase their present honoraria by 100 per cent and will provide a monthly allowance for barangay tanods as well, including the creation of a National Barangay Benefits Augmentation Fund, that will help augment the financial needs of the barangay which cannot afford to shoulder the increase;

WHEREFORE, foregoing premises considered, on MASS MOTION of the BODY; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution STRONGLY SUPPORTING HOUSE BILL NO. 11749 WHICH SEEKS TO INCREASE THE BENEFITS OF THE COUNTRY'S BARANGAY OFFICIALS;

ADOPTED, September 14, 2000.
