WHEREAS, a bill has been passed on third and final reading at the Nouse of Representatives increasing the benefits of the nation's barangay officials;

WHEREAS, barangay leaders deserve an increase in benefits for they are the ones who stand at the front-line of governance and that it will enable also to promote a high level of service among barangay officials by helping them address their own needs;

WHEREAS, this measure will increase their present honoraria by 100 per cent and will provide a monthly allowance for barangay tanods as well, including the creation of a National Barangay Benefits Augmentation Fund, that will help augment the financial needs of the barangay which cannot afford to shoulder the increase;
