

RESOLUTION NO. 2000-172

RESOLATION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN FOR AND IN BYHALF OF THE CITY GOVERNMENT OF ORMOC A RENEWED CONTRACT OF LEASE WITH CHITO'S CHOW PROVIDED, THAT THE TERMS AND CONDITIONS HEREIN ENUMERATED BE INCORPORATED IN THE RENEWED CONTRACT OF LEASE.

AEREAS, this august Body is in receipt of a letter dated 05 July from the City Mayor Eufrocino M. Codilla, Sr., requesting for a 2000 resolution authorizing him to enter into a renewed contract of lease with Chito's Chow for a period of five (5) years under such terms and conditions which are beneficial to the City of Ormoc;

WHEREAS, pursuant to said request, the Committee on Laws and Ordinances met and after review of the original Contract of Lease agreed that the following terms and conditions be incorporated in the renewed Contract of Lease which are deemed beneficial to the City Government, as follows:

- The period for the renewed contract shall be for five (5) years only as provided for under Section 14 of the original contract of leases
- The lease shall commence retroactive to the date of expiration of said original contract of lease;



- 3. The monthly rate shall be no less than Ten Thousand Pesos (₱10,000.00) a month payable every first week of the month with an escalation rate of Ten per cent (10%) per year;
- 4. The lessee is prohibited to sub-lease the leased premises as well as renounce, quitclaim and waive its right to any third person or entity;
- That promenaders shall be allowed to use the comfort rooms of the leased premises;
- 6. The lessee shall not introduce permanent improvement whatsoever on the leased premises without the knowledge or written consent of the city;
- 7. That the area leased shall now cover Seven Hundred Seventy (770) square meters.

WHEREAS, this august Body has considered said request reasonable, hence, same be accorded due course of action.

WHEREFORE, foregoing premises considered, on motion of City Councilor Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, jointly seconded by City Councilors Mariano Y. Corro and Sotero M. Pepito; be it

RESOLVED, AS IT IS MEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EURROCINO M. CODILLA, SR., TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC A RENEWED CONTRACT OF LEASE WITH CHITO'S CHOW PROVIDED, THAT THE TERMS AND CONDITIONS HEREIN ENUMERATED BE INCORPORATED IN THE RENEWED CONTRACT OF LEASE;

ADOPTED, October 12, 2000.

RESOLVED, FURTHER, that in the event the renewed Contract of Lease be executed, a copy of the same be furnished to the Sangguniang Panlangsod ng Ormoc;

RESOLVED, FURTHERMORE, to furnish copies of this resolution, each to His Honor, the City Mayor; the City Administrator, the City Legal Officer, Ms. Luz B. Larrazabal, Lessee, c/o Chito's Chow and others concerned, -in Ormoc City;

CARRIED by Ten (10) Affirmative Votes with One (1) Abstention registered by City Councilor Claudio F. Larrazabal.
