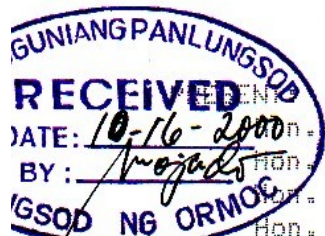

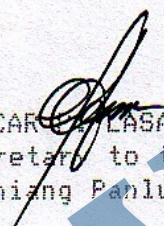

ADOPTED, October 12, 2000.

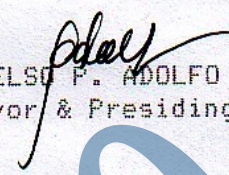
