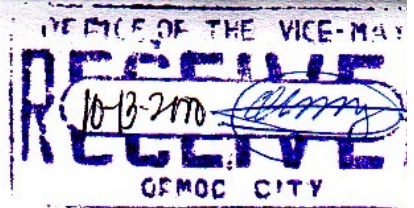
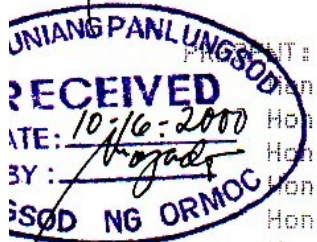

RESOLUTION NO. 2000-177

A RESOLUTION REQUESTING THE ORMOC CITY LOCAL SCHOOL BOARD, THROUGH ITS CHAIRMAN, THE HONORABLE CITY MAYOR EDEROCINO M. CODILLA, SR. AND DR. VIOLETA ALOCILJA, CO-CHAIRMAN, FOR THE CONSTRUCTION OF A BUILDING TO HOUSE THE TWENTY (20) UNITS PERSONAL COMPUTERS DONATED BY THE SECRETARY OF THE DEPARTMENT OF TRADE AND INDUSTRY (DTI) HONORABLE MAR ROXAS TO THE LINAO NATIONAL HIGH SCHOOL.

WHEREAS, the Linao National High School, this city, is a recipient of Twenty (20) units personal computers donated by Hon. Mar Roxas, Secretary to the Department of Trade & Industry for them to be able to learn the importance of computers and to be able to equip themselves in preparation for global competition;

WHEREAS, lately however, said units of Personal Computers were returned to the office of origin for the reason that the recipient has no building to house said donated computers;

WHEREAS, it is in this sense that this august Body is seeking the assistance of the Local School Board, this city in order to house the said donated units and thereby enhancing the capabilities of the students in their quest for computer literacy;
