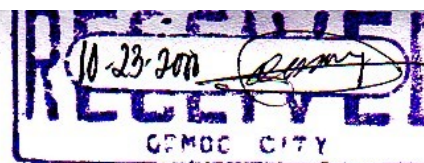
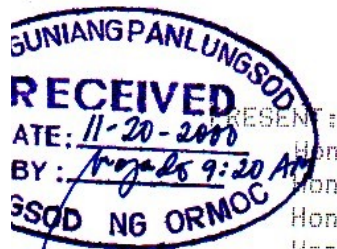

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE
THE AMOUNT OF THIRTEEN THOUSAND TWENTY FOUR PESOS &
16/100 (P13,024.16) AGAINST THE PROVISION FOR PRIOR
YEAR'S OBLIGATION, A NON-OFFICE APPROPRIATION IN THE CY
2000 ANNUAL BUDGET TO SETTLE THE TELEPHONE BILLS OF THE
SANGGUNIANG PANLUNGSOD FOR THE PERIOD MAY 1999 TO
JANUARY 2000.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 04
October 2000 re: request for a Supplemental Appropriation from the
Honorable City Vice Mayor in the amount of THIRTEEN THOUSAND TWENTY FOUR
PESOS & 16/100 (P13,024.16) for payment of Sangguniang Panlungsod
Telephone Bills for the period May 1999 to January 2000;

WHEREAS, the City Budget Officer through 3rd Indorsement dated 10
October 2000 has recommended that authority be granted for City
Accountant to charge said request against the Provision for Prior Year's
Obligation, a non-office appropriation in our CY 2000 Annual Budget;

WHEREAS, the City Treasurer through 5th Indorsement dated 13
October 2000 has stated that the same be charged against the provision
for prior year's obligation, subject however, to accounting and auditing
rules and regulations;

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE AMOUNT OF THIRTEEN THOUSAND TWENTY FOUR PESOS & 16/100 (P13,024.16) AGAINST THE PROVISION FOR PRIOR YEAR'S OBLIGATION, A NON-OFFICE APPROPRIATION IN THE CY 2000 ANNUAL BUDGET TO SETTLE THE TELEPHONE BILLS OF THE SANGGUNIANG PANLUNGSOD FOR THE PERIOD MAY 1999 TO JANUARY 2000;
