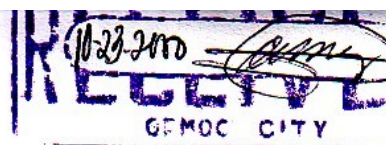

A RESOLUTION APPROVING TAX ORDINANCE NO. 001-2000 OF THE
BARANGAY COUNCIL OF BARANGAY NAUNGAN, THIS CITY,
ENTITLED: "AMENDING FURTHER TAX ORDINANCE NO. 001-93
DATED SEPTEMBER 12, 1993 AS AMENDED BY TAX ORDINANCE
NO. 001-99 DATED JANUARY 17, 1999 BY INSERTING SUB-
SECTIONS 2C (6) TO (11) AND SECTION 5 (A) AND (B)
THEREOF."

WHEREAS, this Sanggunian is in receipt of Resolution No. 017-2000
from the Barangay Council of Naungan, this city embodying Tax Ordinance
No. 001-2000 entitled: "AMENDING FURTHER TAX ORDINANCE NO. 001-93 DATED
SEPTEMBER 12, 1993 AS AMENDED BY TAX ORDINANCE NO. 001-99 DATED JANUARY
17, 1999 BY INSERTING SUB-SECTIONS 2C (6) TO (11) AND SECTION 5 (A) AND
(B) THEREOF;"
