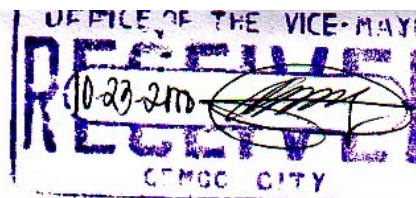

WHEREAS, the construction of New Slaughterhouse Building will not be implemented this year, since the City Planning and Development Office is still evaluating some alternative sites other than the identified site due to the criteria set by NMIC;

WHEREAS, the installation of road studs is not also possible this year since their request to install the road studs at the bridge approaches has been denied for the reason that their project has not yet been turned over by the contractor to the JICA office and to the DPWH;

WHEREAS, the City Development Council has approved the said realignment to maximize the utilization of funds;

WHEREAS, the City Mayor Eufrosino M. Godilla, Sr., through his letter dated October 19, 2000 requested the august Body for urgent and appropriate legislative action, considering the increasing value of dollar to our peso;

WHEREFORE, foregoing premises considered, on motion of City Councilor Claudio P. Larrazabal, Chairman, Committee on Infrastructures, jointly seconded by City Councilor Sotero M. Pepito and Dennis Y. Capuyan; be it
