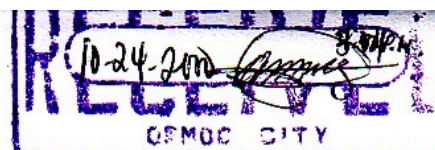

concerned, -all in Ormoc City;


