

Councilors Mariano Y. Corro and Dennis Y. Capuyan; be it


RESOLVED, to pass a resolution APPROVING BARANGAY SUPPLEMENTAL

ADOPTED, November 09, 2000.


RESOLVED FURTHER, to furnish copies of this resolution each to His
