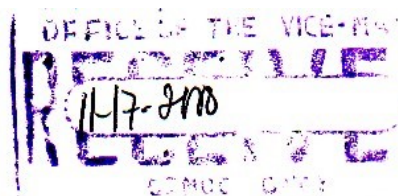
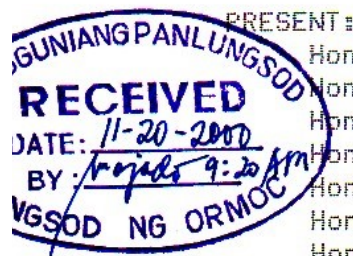

RESOLUTION NO. 2000-199

A RESOLUTION RESPECTFULLY REQUESTING THE ENERGY REGULATORY BOARD THROUGH ITS CHAIRMAN TO CONDUCT THE HEARING AND OTHER SIMILAR HEARINGS OF THE APPLICATION FOR AUTHORITY TO INCREASE ELECTRIC RATES WITH PRAYER FOR PROVISIONAL AUTHORITY OF LEYECO V IN ORMOC CITY, INSTEAD OF CONDUCTING THE SAME AT THE ERB HEARING ROOM, PASIG CITY.

WHEREAS, this Sanggunian is in receipt of copies of the ORDER and NOTICE OF PUBLIC HEARING of the application for authority to increase electric rates with prayer for provisional authority of LEYTE V ELECTRIC COOPERATIVE (LEYECO V) of Ormoc City filed with the Office of the Energy Regulatory Board on October 16, 2000;

WHEREAS, as stated in the Notice of Public Hearing, a portion of which states that, "The Board has set the said application for hearing on November 27 and 28, 2000 at two o'clock (2:00 P.M.) in the afternoon at the ERB Hearing Room 15th Floor, Pacific Center Building, San Miguel Avenue, Ortigas Complex, Pasig City;

WHEREAS, consumers covered by LEYECO V are clamoring for the reason that they cannot participate in the said public hearing nor air their views as regards the same, hence, this request;

WHEREFORE, foregoing premises considered, on motion of City Councilor Dennis Y. Capuyan, Chairman, Committee on Energy Development and Conservation, severally seconded by City Councilors Chiqui B. Labagala, Mariano Y. Corro and Jose C. Alfaro, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RESPECTFULLY REQUESTING THE ENERGY REGULATORY BOARD THROUGH ITS CHAIRMAN TO CONDUCT THE HEARING AND OTHER SIMILAR HEARINGS OF THE APPLICATION FOR AUTHORITY TO INCREASE ELECTRIC RATES WITH PRAYER FOR PROVISIONAL AUTHORITY OF LEYECO V IN ORMOC CITY, INSTEAD OF CONDUCTING THE SAME AT THE ERB HEARING ROOM, PASIG CITY;

RESOLVED, FURTHER, to vehemently object to the prospective increase of electricity rates within the areas covered by LEYECO V;

RESOLVED, FURTHERMORE, to request other municipalities under LEYECO V to pass a similar resolution;

ADOPTED, November 16, 2000.

Codilla, Sr., City Mayor, Ormoc City; the City Administrator, the City Legal Officer, to the Municipalities of Albueria, Kananga, Matag-ob, Isabel, Merida, Palompon, Villaba, Calubi-an, San Isidro, Tabango, and Leyte, Leyte, and others concerned;
