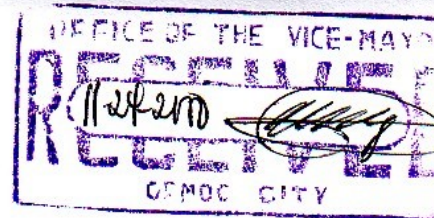
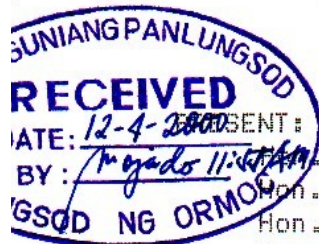

NOVEMBER 30, 2000 IS A HOLIDAY;




