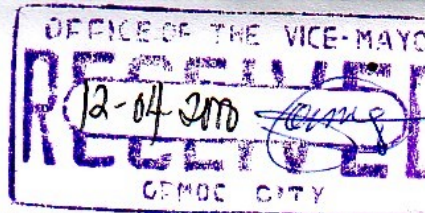
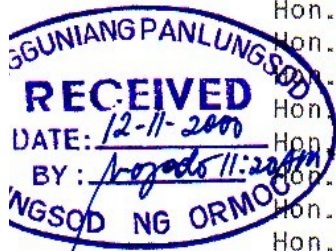

Councilors Dennis Y. Capuyan and Fernando P. Parrilla; be it


RESOLVED, to pass a resolution APPROVING THE ANNUAL BUDGET FOR CY

ADOPTED, November 29, 2000.


RESOLVED FURTHER, to furnish copies of this resolution each to His
