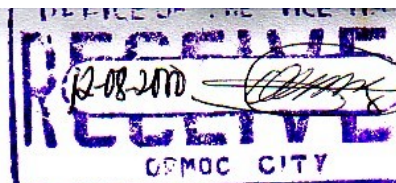
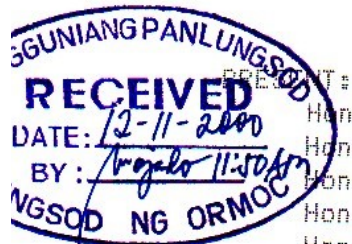

RESOLUTION NO. 2000-208

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN AND CONFORM TO THE MEMORANDUM OF AGREEMENT (MOA) TO BE ENTERED INTO BETWEEN THE CENTER FOR HEALTH DEVELOPMENT REGIONAL FIELD OFFICE NO. VIII AND THE PAGTINABANGAY FOUNDATION, INC., FOR A PROJECT TO BE IMPLEMENTED IN BARANGAY GA-AS FOR THE MANOBO TRIBE, AND A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN AND CONFORM TO THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BETWEEN THE CENTER FOR HEALTH DEVELOPMENT REGIONAL FIELD OFFICE NO. VIII AND THE PAGTINABANGAY FOUNDATION, INC., IN CONNECTION WITH THE DEPARTMENT OF HEALTH REGIONAL OFFICE NO. VIII PARTNERSHIP FOR COMMUNITY HEALTH DEVELOPMENT TO BE IMPLEMENTED IN BARANGAY GA-AS.

WHEREAS, this Sanggunian is in receipt of copies of two (2) MOA's between:

1. the Center for Health Development and Pagtinabangay Foundation, Inc., which covers the implementation of the Indigenous People's Health Program, and
2. Regional Health No. 8 and Pagtinabangay Foundation, Inc., which is in connection with the DOH-8's Partnership for Community Health Development;

WHEREAS, both MOA's have been referred to this august Body with a request that authority be granted the City Mayor to sign the same;

WHEREAS, the City Legal Officer through 1st Indorsement dated 14 November 2000 has stated that "the signing of the MOA's will redound to the benefit of the City of Ormoc;

WHEREFORE, foregoing premises considered, on motion of City Councilor Dennis Y. Capuyan, Chairman, Committee on Health, jointly seconded by City Councilors Alfredo F. Capahi & Chiqui B. Labagala; be it
