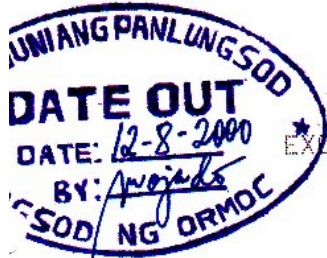
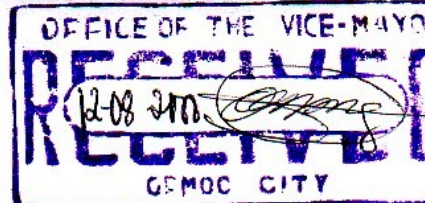
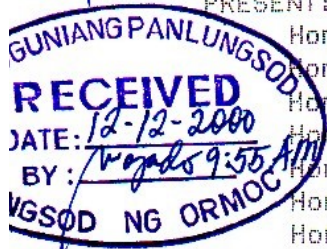

Councilors Dennis Y. Capuyan, Alfredo F. Capahi and Fe S. Lladoc; be it

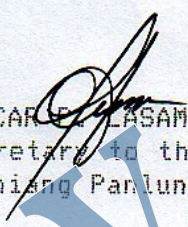
RESOLVED, to pass an omnibus resolution APPROVING BARANGAY

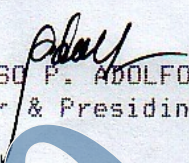
RESOLVED FURTHER, to furnish copies of this resolution each to His
