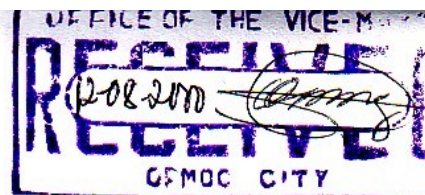


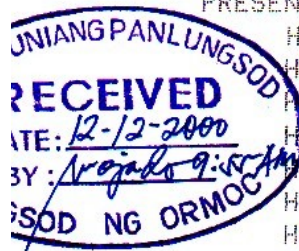

Councilors Mariano Y. Corro, Sotero M. Pepito and Fe S. Lladoc; be it


RESOLVED, to pass a resolution APPROVING BARANGAY SUPPLEMENTAL
