WHEREAS, this Sanggunian is in receipt of Barangay Tax Ordinance
No. 2000-06 of the Brgy. Council of Doña Feliza Z. Mejia, this city,
entitled: "AN ORDINANCE REVISING THE SCHEDULE OF FEES ON BARANGAY
