

A RESOLUTION AUTHORIXING THE HON. EUFROCING M. CODILLA, SR. CITY MAYOR, THIS CITY, TO SIGN A DEED OF DONATION COVERING YOUR (4) PARCEL OF LAND (LOT NO. 2-J, LOT NO. 2-K, LOT NO. 3-L AND LOT NO. 2-M UNDER TCT NOS. 35139, 55140, 55141 AND 35142, RESPECTIVELY), SITUATED IN THE BARANGAY OF LINAO, ORMOC CITY, IN FAVOR OF RUALITIED BENEFICIARIES FOR LOT TITLING OF WORLD VISION AND PART OF PHILRADS RESETTLEMENT AREAS PER LIST HERETO ATTACHED SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS STATED HEREUNDER.

WHEREAS, after the flash flood brought about by typhoon "URING" on Wovember 5, 1991, the City Government of Ormoc established different resettlement sites in Ormoc City to accommodate the flood victims;

WHEREAS, this august Body is in receipt of a request for the passage of a resolution from the Hon. City Mayor authorizing him to sign a Deed of Donation by and between the City Government of Ormoc as Donor and the qualified beneficiaries per list herein attached, for titling of world vision and part of PHILRADS as Donees;

WHEREAS, this Sangguniang believes that the full development of these resettlement sites can only be attained at a fast pace if the resettlement area will be donated to its qualified occupants;

WHEREFORE, FOREGOING PREMISES, considered, on motion of City Councilors Nepomuceno P. Aparis I, Chairman, Committee on Laws and Ordinances, severally seconded by City Councilors Mariano Y. Corro, Sotero M. Pepito, Alfredo F. Capahi, Chiqui B. Labagala & Fe S. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution authorizing the Hon. Eufrocino M. Codilla, Sr., City Mayor, this city, to sign a Deed of Donation covering four (4) parcel of land (Lot No. 2-J, Lot No. 2-K, Lot No. 2-L and Lot No. 2-M under TCT Nos. 35139, 35140, 35141 and 35142, respectively) situated in the Barangay of Linao, Ormoc City, in favor of the qualified beneficiaries for lot titling of World Vision and part of PHILRADS resettlement areas per list hereto attached subject to the following terms and condition:

- The homelots shall only be donated to the qualified occupant as determined and recommended by concerned government agency;
- That individual titling of the homelots donated shall be borne solely by the beneficiary;
- 3. That these homelots shall not be transferred or assigned to any person, natural or juridical within a period of twenty five (25) years from date of the individual titling thereof, except by hereditary succession, and any transfer or assignment in violation thereof shall be null and void;
- 4. That the donee may mortgage his homelot to any financial and/or home-financing institution, to secure a loan for the construction/repair/remodeling of a house in said lot;
- 5. That conditions No. 3 and 4 above shall be annotated in the certificate of title that may be issued to the individual donee.

ADOPIED, December 7, 2000.

RESOLVED, FORTHER, to furnish copies of this resolution each, to bis Honor, the City Mayor; the City Legal Officer, the City Social Welfare and Nevelopment Officer, the Brgy. Chairman, Brgy.
