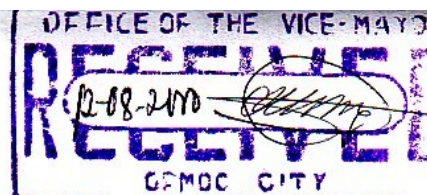
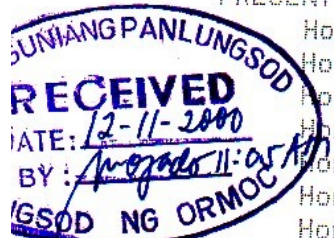

RESOLUTION NO. 2000-214

A RESOLUTION DECLARING ORMOC CITY UNDER THE "STATE OF
CALAMITY" DUE TO THE EXTENT OF DAMAGE CAUSED BY TYPHOON
"TOYANG".

WHEREAS, this august Body is in receipt of a letter dated 04
December 2000 from the Honorable City Mayor, Eufrocino M. Codilla, Sr.,
thru the Honorable Celso P. Adolfo, Vice Mayor & Presiding Officer this
city, the full text of which is hereunder cited as follows:

Gentlemen:

The occurrence of the recent typhoon "Toyang" that hit
Eastern Visayas and of which Ormoc was declared under Storm
Signal No. 3, has again injured the economy of the City.
Reports from our City Social Welfare and Development Office
(CSWDO) and City Agricultural Services Office (CASO) showed
that crops and properties are greatly destroyed.

Cognizant therefore of the extent of damage the said typhoon
has caused to the city's economic condition, and concerned
very much of the welfare of our constituency, may I
respectfully request that august body for the passage of a
resolution declaring Ormoc City under the state of calamity.

I hope you can extend this matter your immediate favorable action.

WHEREAS, the authority to determine and declare an area or a portion thereof as calamity area is vested solely on the local sanggunian concerned as provided for by Sec. 1 of Republic Act No. 8185 entitled, "AN ACT AMENDING SECTION 524 (d) OF REPUBLIC ACT NO. 7160 OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991 dated June 11, 1996 and quoted hereunder as follows:

"SECTION 1. Section 324 (d) of Republic No. 7160 is hereby amended to read as follows:

(d) Five percent (5%) of the estimated revenue from regular sources shall be set aside as annual lump sum appropriations for the relief, rehabilitation, reconstruction and other works or services in connection with calamities which may occur during the budget year. Provided, however, That such fund shall be used only in the area or portion thereof of the local government unit or other areas affected by a disaster or calamity, as determined and declared by the local sanggunian concerned";

WHEREAS, the Sangguniang Panlungsod ng Ormoc mindful of the plight of its constituents has considered said request reasonable, hence, same must be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor, Nepomuceno P. Aparis, I, Chairman, Committee on Laws & Ordinances, severally seconded by City Councilors Dennis Y. Capuyan, Chiqui B. Labagala & Fe S. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution DECLARING ORMOC CITY UNDER THE "STATE OF CALAMITY" DUE TO THE EXTENT OF DAMAGE CAUSED BY TYPHOON "TOYANG";

ADOPTED, December 7, 2000.

RESOLVED, FURTHERMORE, to furnish copies of this resolution each to His Honor, the City Mayor, the City Administrator, the City Legal Officer, the City Treasurer, the City Accountant, the City Budget Officer, the City Auditor and others concerned, -all in Ormoc City;
